

## Issue of Shares and Cleansing Notice

Battery Age Minerals Ltd (ASX: BM8; “**Battery Age**” or “the **Company**”) advises that initial tranche of the \$1.5 million Placement announced on 4 February 2025 has settled with the issue of 15,731,707 new fully paid ordinary shares (“Shares”).

As previously announced, the Placement is taking place in two tranches, with the Directors and Management Placement worth \$210,000, to take place subject to shareholder approval under ASX Listing Rule 10.11, to be sought at a general meeting of shareholders proposed to be held shortly.

An Appendix 2A has been lodged together with this announcement in respect of the Shares.
