COURT APPROVES SCHEMES OF ARRANGEMENT

Bigtincan Holdings Limited (**ASX: BTH**) (**BTH** or the **Company**) is pleased to announce that the Supreme Court of New South Wales (**Court**) has today made orders approving the schemes of arrangement under which:

- Big Wombat Pty Ltd, an entity ultimately owned by a fund managed and advised by Vector Capital Management, L.P. or its related entities, proposes to acquire 100% of the issued share capital of BTH for \$0.22 per Scheme Share (**Share Scheme**); and
- certain issued options (**Scheme Options**) of BTH would be cancelled for a cash consideration in accordance with the agreed methodologies described in Section 6.5(a) of the Scheme Booklet (**Option Scheme**, together with the Share Scheme, the **Schemes**).

Unless otherwise indicated, capitalised terms used in this announcement have the meaning given to them in the Scheme Booklet in relation to the Schemes dated 26 February 2025 and released to the ASX on 28 February 2025.

BTH expects to lodge an office copy of the Court orders with the Australian Securities and Investments Commission (**ASIC**) on Wednesday, 9 April 2025, at which time the Schemes will become legally effective and binding on BTH Securityholders. If this occurs, BTH Shares will be suspended from trading at the close of trading on Wednesday, 9 April 2025.
