

Scheme Update – Scheme Meeting Postponed

Silk Logistics Holdings Limited (ASX:SLH) (**Silk** or the **Company**) refers to its announcement to ASX dated 27 February 2025, informing the market that Silk would approach the New South Wales Supreme Court (the **Court**) seeking postponement of the Scheme Meeting that was previously scheduled for Friday, 7 March 2025.

- wish to change your vote, then you can do so by lodging a new proxy form or vote in person (or online) at the Scheme Meeting (noting your updated vote will supersede your previous proxy vote); or
- do not wish to change your note, you do not need to take any action.

All times and dates remain subject to change. Any changes will be announced by Silk to ASX.

Silk will keep the market informed of any material developments in relation to the Scheme including in relation to the decision making process of the ACCC and FIRB Approval.
